The analysis was led by A.S.E.L. RO in collaboration with the project partners, ensuring a cohesive approach and shared expertise. Based on predefined criteria and indicators established during the survey design phase, the collected data was meticulously processed and organized. This included creating graphical representations such as charts, tables, and infographics to visually convey the patterns and trends identified in the survey responses.

The quantitative analysis examined measurable factors, including participation rates, demographic breakdowns, and geographic disparities, offering a clear statistical picture of the engagement levels among mobile EU citizens. Simultaneously, a qualitative analysis was performed to interpret open-ended responses and contextualize the numerical findings.

This approach allowed the team to explore the underlying motivations, challenges, and barriers faced by participants, uncovering nuanced insights that might not be captured by quantitative data alone.

The findings from Deliverable D2.4 revealed critical factors contributing to low participation, such as language barriers, lack of information, and limited access to resources. These insights serve as a foundation for developing targeted strategies to address these barriers in subsequent project activities.

By integrating both analytical approaches, Deliverable D2.4 provides a well-rounded perspective that supports evidence-based decision-making and ensures the project remains aligned with the needs of its target groups.

## DELIVERABLE 4.1: INTERIM EVALUATION REPORT

Deliverable 4.1, the Interim Evaluation Report, was completed during the ninth month of the ADAPT project as part of Work Package 4.

#### SUMMARY OF THE SECOND PROGRESS REPORT

These findings laid the groundwork for tailored strategies to enhance youth involvement.

Under Work Package 4, Deliverable D4.1 marked the completion of the Interim Evaluation Report. This mid-cycle assessment evaluated the project's content-related and financial progress, reflecting on management efficiency and providing recommendations for transitioning to subsequent phases. Partners shared feedback on activities and deliverables, ensuring a collaborative and transparent evaluation process.

In Work Package 5, dissemination activities expanded with the completion of Deliverables D5.4 and D5.5. Printed and electronic dissemination materials were developed to promote the project, combining traditional outreach with digital tools. These efforts enhanced visibility, with the project website and partners' platforms reaching thousands of stakeholders.

Additionally, preparations for upcoming events began to ensure smooth execution and effective stakeholder engagement. This progress demonstrates the project's commitment to its objectives and sets the stage for impactful future activities

The event emphasized the importance of cross-cultural collaboration and communication.

Subsequently, Training Material for Youth Mobility in Latvia was developed to prepare participants for seminars on active citizenship and social inclusion. The materials, enriched by contributions from diverse stakeholders, empowered youth to engage effectively in cross-border dialogues and initiatives.

During the Youth Mobility Seminars, partners captured videos and interviews for Youth Mobility Video Making, showcasing participants' experiences. These videos served as promotional tools to amplify the project's visibility and document its impact.

The 2nd Festival Report documented the second youth festival, which expanded on the success of the first. This event utilized video content and participant feedback to highlight achievements and foster engagement among a wider audience.

Finally, the Final Evaluation Report provided a comprehensive review of the project's overall impact. It outlined achievements, identified lessons learned, and proposed recommendations for sustaining the project's outcomes. Together, these deliverables illustrate the ADAPT project's commitment to empowering youth, fostering inclusion, and ensuring long-term impact.
